Rules of site use

- 1. The user personally bears all types of legal responsibility for the published materials: texts, drawings, photos, audio and video materials.
- 2. Administration of this site is not responsible for the

materials content uploaded to your personal account and on the site wall, including reviews and comments. Also it dose not carry out obligatory moderation of works, posts and comments posted in the thematic sections of the site.

- 3. The site administration reserves the full right to delete any materials uploaded to the site, block or delete the profiles of participants, delete the forums they create without giving any reason, including deleting user materials at the request of the copyright holders.
- 4. The publication of works and offensive behavior directed against anyone is prohibited. All issues are resolved with the site moderator in personal correspondence or with the administration by e-mail indicated in the contacts.

5. All materials posted on our website can be viewed and downloaded free of charge for personal use. If you want to use the materials presented on the site for commercial or public purposes, this is possible only with consent and in accordance with the copyright law.

6. It is forbidden to plagiarize and pass off other people's work as their own. Otherwise, the copyright holder may hold you liable under the copyright laws of your country of residence.

It is not recommended to upload the same work to the site. more than once (for example, the same music track in different music sections, etc.)

- IT IS STRICTLY FORBIDDEN to post any materials containing:
- pornography, pedophilia;
- calls to violence, extremism, terrorism, racial or religious hatred;
- ideas and symbols of Nazism and fascism;
- any commercial information and commercial offers;
- senseless flooding, spam, trolling;
- libel, knowingly false information;
- obscene words and expressions, insults;

- materials, the content of which is prohibited by the laws of the country of your residence, as well as posting links to pages that violate

the legislation of a given country;

- personal data and information of a private nature about other persons, without their consent.

The user who violated these rules for the first time,

a warning (account pause) is made for a week. In the case of a second repeated violation, the account is deleted from the site.

- 8. The creators of forums and blogs are OBLIGED to keep them clean and tidy.
- 9. It is forbidden to create fake questionnaires for voting for your work. The works that received points as a result of such actions are deleted.
- 10. It is forbidden to vote from empty one-time questionnaires created for the purpose of voting for one specific job. Such profiles and points will also be deleted.
- 11. It is forbidden to post links to entries in their profiles.
- 12. It is forbidden to post invitations to vote for your or

other people's work in a general chat or chat radio.

13. Bulk mailings in the form of texts, links, sets of emoticons in personal correspondence, comments on works, with invitations to their contests, advertisements, links to

third-party sites, etc., the creation of hack work, in which there is nothing but a link to a third-party author or his work (even if the work is joint), the purpose of which is to advertise other people's or their own works.

- 14. The site has an anti-spam program that allows you to track such actions and automatically block the profiles of violators. On the first violation of this rule, all points for work advertised in this way are reset to zero. In case of repeated violation of this rule, the function is disabled, the account is banned, and the works that received points as a result of such actions will be deleted.
- 15. The site administration reserves the right to use any materials uploaded to the site, at its discretion, within the site or site accounts, in the main social networks: Facebook, Twitter, Google, Vkontakte, Odnoklassniki etc. For example, scrolling audio tracks on a radio site without agreement with the author, and so on.
- 16. Services paid for on the site, in the event of their normal technical implementation, are not subject to return and exchange.

Methods of communication in violation of network ethics are prohibited, manifested in manifestations of various, including veiled forms of aggressive, bullying and abusive behavior (trolling), as well as persecution of a person, associated with humiliation, intimidation or causing psychological harm (cyber humiliation).
- 22. The server administration warns that in some cases errors and malfunctions in the software or the server may appear.
- Users should be sensitive to such situations and, as much as possible, report them to the administrative services.
- 23. All changes in the rules of the site, rating and other things users are notified in the SITE NEWS section. When news appears above the name of this section, the NEW icon starts blinking, which blinks until you open the news section and read the news.
